2. Due to time constraints parent or guardian will be allowed to consult at most two (2) teachers to accommodate more individuals.
3. Schedule for consultation is on a first-sign-up, first-served basis.
4. After the enlistment period, the Subject Teacher will email the student / parent / guardian the consultation time and the Meet link.
5. Parent / Guardian is expected to log in the Meet link sent via email on the scheduled consultation time.
6. All consultations will be conducted via Google Meet and will run for 10 minutes.
7. Should parent / guardian need more time to confer with the subject teacher, an appointment for the following week may be scheduled via the department.
8. If parents cannot be accommodated on the consultation day parent or guardian may be scheduled the following week during the teacher's available time.
9. All consultations will be recorded for reference purposes.

Aside from the designated PTC days, parents / guardians are also welcome to consult by emailing the subject teacher/s, class advisers, or any of the school administrators. Please allow for reply to be sent within 5 days.
